

Bonus Terms & Conditions

Effective Date: 01/08/2024

These Bonus Terms & Conditions ("Bonus Terms") apply to any promotional offers, incentives, or rewards ("Bonus") made available by **SolrCapital AG**, Bahnhofstrasse 37, CH-8001 Zürich, Switzerland ("SolrCapital"). By participating in any Bonus program, you agree to these Bonus Terms in addition to our general **Terms of Use** and **Deposit & Withdrawal Policy**.

1. Eligibility

- Bonus offers are available only to verified account holders who meet the eligibility requirements stated in the promotion.
 - SolrCapital reserves the right to refuse or revoke any Bonus if false or misleading information has been provided during registration or verification.
 - Bonus offers are limited to one per person, household, IP address, or account, unless otherwise stated.

2. Types of Bonuses

- **Welcome Bonus:** May be awarded to new clients upon their first deposit.
 - **Deposit Match Bonus:** A percentage of the deposit amount may be credited as a bonus balance.
 - **Referral Bonus:** May be awarded when introducing new clients who meet specific deposit and trading requirements.
 - **Loyalty or Promotional Bonuses:** Granted under special campaigns or long-term client reward programs.

3. Bonus Crediting

- Bonus amounts will be credited to the client's account as specified in the promotion details.
 - SolrCapital reserves the right to adjust or cancel any Bonus crediting errors.

4. Wagering & Trading Requirements

- All Bonuses are subject to minimum trading volume requirements before they can be withdrawn.
 - Unless otherwise stated, the standard requirement is that the total trading volume must equal at least **25 times** the Bonus amount received.
 - Failure to meet the requirements within the stated time frame will result in the Bonus and any profits derived from it being forfeited.

5. Withdrawal Restrictions

- Bonus funds cannot be withdrawn directly; only profits made after meeting the requirements may be withdrawn.
 - If a withdrawal request is made before completing the required trading volume, the Bonus and related profits will be deducted from the account.

6. Bonus Abuse & Fraud

- Any attempt to abuse Bonus offers (e.g., multiple accounts, collusion, arbitrage, or suspicious trading patterns) will result in forfeiture of the Bonus and potential suspension of the account.
 - SolrCapital reserves the right to take legal or regulatory action in cases of fraudulent activity.

7. Expiration

- Unless otherwise stated, all Bonuses must be used within **90 days** of being credited.
 - Expired Bonuses will be automatically removed from the account.

8. Modification & Termination

- SolrCapital reserves the right to amend, suspend, or terminate any Bonus program at any time without prior notice.
 - Existing Bonus offers already accepted will remain valid until their stated expiry or cancellation by the company.

9. Final Decision

In the event of a dispute regarding Bonus eligibility, fulfillment, or conditions, the decision of SolrCapital shall be final and binding.
